## Camp Columba Covid-19 Risk Protection Policy



-	
Groups/individuals:	All eligible people attending a CVC applicable event at Camp Columba must hold and provide on request a NZ Covid Vaccine Certificate.
Staff & Volunteers: (OSCAR)	Columba employees will be fully vaccinated by 15 Jan 2022 Staff and volunteers attending an OSCAR accredited programme at Columba will be required to be fully vaccinated against Covid 19 & provide details of their vaccination status.
Campers (OSCAR)	Vaccine passes for participants is prohibited for OSCAR services i.e. campers & caregivers transporting/signing in campers will not be required to present a Vaccine Pass.

In developing this policy, we have conducted a risk assessment for attendees and assessors following the Covid 19 Risk assessment principles. We have considered:

- Travel to events from multiple regions
- The close contact mode of operation outdoor instruction entails
- The length of time members/participants are in close proximity to one another

Additionally, we have considered:

- Our obligations under the Covid-19 Risk Protection Framework
- Our responsibilities under the Health and Safety at Work Act, to take all reasonable and practicable steps to ensure the safety of our volunteers, campers, and staff
- The impact of halting our camps and programmes
- The intent of the education mandate in protecting our young people

**When:** This policy will come into effect when the Covid-19 Risk Protection Framework comes into effect.


**How:** Prior to attending a CVC applicable event at Camp Columba members and participants (where applicable) must provide, upon request, a NZ Vaccine Certificate/Pass.

**Review:** We recognise health and safety requirements relating to Covid-19 continue to evolve. This policy will be reviewed regularly, and if necessary modified to align with any current Ministry of Health requirements.

Glossary:

**Policy:** 

CVC -	Covid Vaccine Certificate or MyVaccine Pass
CVC Applicable Events -	Events, camps and programmes where the NZ Covid-19 Protection Framework dictates the need for Vaccine Certificates/Passes.
